There has never been a better time to support your University

On 1st August 2008 the Government launched a £200 million Matched Funding Scheme to match gifts raised by English Universities.

What does this mean for your University?

The Government will give an additional £1 for every £3 donated

Government funding will be applied **both** to the gift and the value of Gift Aid that we can claim from the original donation.

The University can potentially increase your gift by 70% through Gift Aid and the Matched Funding Scheme at no extra cost to you

The chart below shows the impact of all contributions to the University – with no additional cost to the donor.

If you pay UK income or capital gains tax, the University is able to reclaim the tax which you have paid on any of your gifts to us in the last six years.
